Also obtained a commitment to provide a proposal to "cold seal" cracks on Hermosa Paloma as well as do some shoulder and grading work (shoulder and grading @ \$250 gravel, \$925 tractor. \$2500 minimum. Proposal for Hermosa Paloma not yet received.)

Kirby said that he would invite Comm. Will Conley to attend the RMR winter meeting in January, to update everyone present on the county takeover of RMR roads.

MOTION: Rick made a motion that the roads committee put together and send out to the POA, a report, which would be supported by the board, to promote the road maintenance take-over by the county. Bobby seconded the motion. The vote was all "ayes". Motion passed.

After a short discussion, Kirby said that he would send out a "head's up" to the POA concerning road side wash-outs and culvert issues. The concern was that some residents have issues with driveway culverts that result in erosion of RMR roads (crushed or clogged culverts, inadequately sized, etc.)
